



## WHEREAS:


- A) First Party is a Higher Educational Institution named: **SRI BHARATHI ENGINEERING COLLEGE FOR WOMEN**

## CLAUSE 2 SCOPE OF THE MoU

- 2.1 **Incubation Centre Establishment:** A provision of Incubation Centre in the college campus to support the student projects, product development, In-house internship to the students of Sri Bharathi Engineering College for Women.


